




Android users should consult the documentation for their phone/ tablet to confirm BLE capability.







Caring for SailBot

We've taken great care to design SailBot to be weather resistant and provide years of reliable service.

To keep your unit looking and functioning like new it is important to care for SailBot as you would any other electronic device in a marine environment.


- Do not submerge SailBot or place it in a location prone to splashing
- Do not allow water to pool in the power switch for prolonged periods
- Insert splash protector into charging port whenever not charging
- Remove salt spray by lightly rinsing with fresh water upon return to dock
- Dry unit with a clean towel after each use



SAILBOT CLASSIC

To charge SailBot

- Plug charger into wall
- Flip splash protector from charging port
- Insert jack completely into charging port*
- We recommend NOT fastening retaining ring
- For maximum battery life, keep SailBot connected to charger when not in use





SAILBOT SPORT/MAX

*ALWAYS disconnect the charger from SailBot before use! Leave the charger in the club please.

Turn SailBot on and off using the silver push-button power switch located on the unit.

Button illuminates when power is on.









SailBot Sport & MAX have a threaded air valve that may be closed during non-use to provide additional water resistance.

Please verify that this valve is open during operation so the air pump has enough airflow for horns.

Step One: Make sure SailBot is turned on, then:












Place SailBot in a safe location away from Race Committee ears and turn unit on. SailBot's battery can last all day so no need to turn on and off between races.

On sequence selection screen, tap "Create a custom sequence"

Set total sequence duration



Tap time box where you'd like a horn then select length of signal (same for flag reminders if desired)

To see more/less detailed time increments, tap Zoom In and Zoom Out



When the new custom sequence is complete, tap Save enter a name for the sequence then tap Save to keep it!



Deleting a Sequence

To delete a custom sequence, tap "Edit" in the sequence selection page then tap "-" next to sequence to be deleted. You cannot delete the sequence that is currently set to run. Select a sequence you want to keep first, then go into edit mode to delete.



SailBot, LLC ("SailBot") warrants to the owner of the enclosed product that the product contained in this box ("Product") will be free from defects in materials and workmanship for a period of one (1) year from the date of delivery following the original retail purchase (the "Warranty Period"). If the Product fails to conform to this Limited Warranty during the Warranty Period, SailBot will, at its sole discretion, either (a) repair or replace any defective Product or component; or (b) accept the return of the Product and refund the money actually paid by the original purchaser for the Product. Repair or replacement may be made with a new or refurbished product or components, at SailBot's sole discretion. If the Product or a component incorporated within it is no longer available. SailBot may replace the Product with a similar product of similar function, at SailBot's sole discretion. This is your sole and exclusive remedy for breach of this Limited Warranty.
